

## **GATEWAY TO FREDERICK METROPOLITAN DISTRICT NOS. 1-6 2020 CONSOLIDATED ANNUAL REPORT**

Pursuant to the Service Plans for the Gateway to Frederick Metropolitan District Nos. 1-6 (collectively, the “Districts”), the Districts are required to provide an annual report to the Town of Frederick (the “Town”) with regard to the following matters:

To the best of our actual knowledge, for the year ending December 31, 2020, the Districts make the following report:

1. A narrative summary of the progress of the Districts in implementing their Service Plans for the report year.

The Districts remained largely inactive during 2020.
